

NUNER PRIMARY CENTER UNIFORM POLICY

Uniforms will consist of:

- Short or long sleeved solid polo shirt with a collar or solid collared dress shirt. Only solid shirts of the following colors are permitted: light blue to navy/dark blue, or white. No insignia of any kind. All shirts must be tucked in at all times.
- No bare midriffs, tank tops, or tube tops of any kind (nor can these be worn over the polo or dress shirt). Any shirt or undershirt worn under the polo or dress shirt must be light blue to navy/dark blue, or white.
- Solid cardigans, sweaters, or sweatshirts may be worn over the polo shirt or collared dress shirt in the following colors: light blue to navy/dark blue, or white. No hooded garments. No stripes. No coats or light jackets.
- Pants, slacks, shorts, capris and skirts/skortts must be navy or khaki. Shorts and capri's (no knit or fleece material) of the above colors may be worn from April 1st through October 30th only. Skirts/skortts and shorts may be no shorter than three inches below the finger tips and/or three inches above the knees. Leggings may be worn underneath skirts/skortts as long as the leggings are solid navy or white in color. No **cargo style** pants/shorts/capris. No sweatpants. No jeans (blue or black) are allowed at any time.
- Clothing must fit as designed, not oversized or too snug. **No sagging.** No skinny jeans or pants. No jeggings. Modifying clothing in any way is not permitted. No torn or ripped clothing.
- Athletic teams or clubs will be limited to an approved jersey or team/club shirt worn over the polo or dress shirt (the collar must be visible) and only on the day of an event. Jersey or shirt must be tucked in.
- Approved Nuner spirit wear (t-shirts, sweatshirts) may be worn over the polo or dress shirt (the collar must be visible). T-shirts must be tucked in. No hooded garments.
- Students must wear athletic/tennis footwear. All shoes should be closed-toed shoes.

Uniform Accessories:

- Socks/hose/tights are solid color (brown, black, white, or blue): no prints/stripes/designs.
- Although NOT REQUIRED, ties are acceptable accessories to their uniforms. Ties: light blue to navy/dark blue, or white must be worn with a uniform dress shirt. No wording, emblems, caricatures permitted on ties.
- Modest jewelry is permitted and sunglasses may be utilized for outdoor recess only.
- Students wearing pants with belt loops must wear a belt (brown, black, or tan/brown) with standard belt buckle if the pants appear to be too baggy and cause sagging without the use of a belt.
- Footwear must be closed toe and closed heels. (No slide-ons, flip-flops, slippers, moccasins, toe shoes, or sport sandals of any kind). Velcro straps must be woven through loop and secured/closed.

The following are NOT permitted to be worn at school, on the school campus or at school events:

- Revealing or suggestive clothing
- Clothing & jewelry containing messages or images about alcohol, drugs, tobacco, violence, cults, racism, profanity, gang membership, or suggestive content
- Hats, bandannas, sweatbands, hairnets, "do rags", headscarves
- Pajamas, boxer shorts, biker shorts, hip huggers or low waist pants, micro mini skirts, short shorts (shorts & skirts must be three inches (3") below fingertips). No torn or ripped clothing
- Chains, spikes, gloves, slippers of any kind

- Saggy pants or clothing that reveals/displays undergarments
- Hairstyles (for example: Mohawks, spikes, cutting of hair designs, etc.) or hair coloring (for example: pink, green, red, etc.) which draw undue attention to a student or cause distractions to the educational environment
- Other items or styles that are not in the spirit of the uniform policy or that draw undue attention to a student or cause distractions to the educational environment

Cost and Availability:

Uniform clothing may be purchased at any of the local merchants (Meijer, Target, Wal-Mart, JC Penny, Max 10, K-Mart, CitiTrends, St. Vincent de Paul, and Goodwill). Anticipated cost of the uniform should be significantly less than what would typically be spent.

Non-Compliance Consequences

1st non-compliance:

- Correct infraction
- Student signs uniform policy

2nd non-compliance:

- Correct infraction
- Parent contact

3rd non-compliance

- Correct infraction
- Parent contact
- No extra-curricular activity(ies)

4th non-compliance

- Correct infraction
- Parent contact
- Constitutes insubordination. Consequences outlined in the Primary Student Code of Conduct

Exceptions

- When a student's parents or guardians have secured an exemption from the uniform program.
- While an appeal of an exemption is pending under the described School Uniform Policy.
- During the first five days after transferring from a non-uniform school within the district or from outside the district.
- When a student is on campus outside of normal school hours.
- The school principal shall have the discretion to determine "flexible uniform days" to allow students to have varying dress down days.
